




### **Step 2: Receive Email**

# Frequently Asked Questions

### **■** What is a Nominee Director?

A Nominee Director is a **Local Singaporean resident director** that will be registered in your company's ACRA records. The main role of the Nominee Director **for the purpose of compliance** and to meet the stipulatory requirement. As long as you meet the local resident director requirement, the company can be 100% foreign owned (whereby you and/or your partner(s) own 100% shares in the company).

The Nominee Director will not, and cannot be involved in the operations or management of the company; and will not be obligated to execute any official documentation that involves the management and operations of the company.

By engaging Leftright Corporate's representative Nominee Director, you can be assured in safe, reliable, knowledgeable and professional service.

## ■ Why do I need to fill up a KYC (Know-your-client) form?

Since we'd be your nominee director, our name is on the line too. Although a nominee director is mainly for compliance, the legal requirements of any local director exists as well. In rare, but some cases, we have to reject clients from engaging our service, due to reasons including conflict of interest, or those who simply do not pass our internal risk analysis.

## ■ Do I need to put a security deposit?

It depends on our internal assessment. Factors such as business activities, KYC forms and such, play a part. Usually we would need a deposit when you engage in our incorporation service with the nominee director only. However, if you engage Leftright Corporate with other compliance matters such as tax computation and filing, we usually wouldn't need a deposit then.
